POSITION SUMMARY:

Under the leadership of the executive director, develops, maintains and implements all aspects of a quality improvement program. In partnership with the medical director, develops, implements, and monitors medical treatment protocols delivered in the field by all EMS personnel (MFRs/EMTs/Paramedics). In collaboration with appropriate governance committees, leads and oversees all educational activities/projects/offerings. Serves as the first point of contact for all clinical EMS inquiries.

MAJOR DUTIES AND RESPONSIBILITIES:

- Assists in the development, implementation, and oversight of QA/QI programs to assess
 compliance with medical treatment protocols delivered in the field by EMS personnel to ensure
 the quality of emergency and non-emergency services. Monitors and interprets LSA data to ensure
 protocol compliance and improvement. Reports findings to key stakeholders and leads and
 monitors all quality assurance activities for improving outcomes and maintaining continued
 improvement. In partnership the executive director and medical director, designs and conducts
 special studies as necessary.
- In cooperation with the Business Operations Coordinator, oversees licensure process for all annual re-licensure and any new licensure requests.
- In cooperation with regional partners and governance committee representatives, establishes and maintains a database of questions and scenarios for skills verification/protocol assessment activities and updates testing with new or changed protocols. Coordinates annual assessment and any special assessments to verify competencies of EMS providers.
- In partnership with the Business Operations Coordinator, oversees all CE Sponsorship activities, including consortium compliance and tri-annual certification. Oversees, prepares and conducts

MCA education initiatives for LSAs and it's providers. Develops lesson plans and curriculums for training and education initiatives.

- Serves as the first point of contact for all clinical/EMS inquiries to the MCMCA. Oversees all EMS
 protocol activities locally, regionally and state-wide, including but not limited to creation of new
 protocols, updates, etc.
- Coordinates the PSRO investigations and activities. Creates monthly agenda, prepares and distributes correspondence regarding PSRO actions/remediation.
- Leads and coordinates annual MCI exercise(s) in collaboration with our governance committee, life support agency representatives and other key stakeholders across Macomb County and the region, as appropriate.
- Leads, coordinates and/or participates on various local and regional MCA Committees. Serves on State committees as assigned.
